Who we are?


LIBNOR is a public institution attached to the Ministry of Industry. It was established by a law dated 23/7/1962 as the sole authority to issue, publish and amend Lebanese standards and to give the right to use the Lebanese Conformity Mark (NL Mark).

National standards cover all products falling within the management system, agro-food, chemical, petroleum, construction, mechanical, electro technical and other sectors. Moreover, Lebanese standards deal with measurements, conventions, symbols, methods of analysis and testing, codes of practice for technical work and technical rules and codes for buildings, etc...

In fact, LIBNOR has a key role in developing, through standardization, the quality of the industrial products to be competitive in the domestic and international market and at the same time to protect the consumers from unsafe products.

Libnor is member of the International Organization for Standardization (ISO), , the Codex Alimentarius Commission , the Standards and Metrology Institutes for Islamic Countries- SMIIC, the RNF- Reseau Normalisation et Francophonie and AIDMO. LIBNOR is also Affiliate member to the European Committee for standardization – CEN

In 2008, Libnor was the first Lebanese public institution certified against ISO 9001:2008



Standards development

Standards development

Lebanese standards are developed according to the following principles:


Industry-wide: Global solutions are provided to satisfy industries and customers in Lebanon. **Voluntary:** Lebanese standardization is market-driven and is therefore based on voluntary involvement of all interests in the market-place.

Consensus: The views of all interests are taken into account: manufacturers, vendors and users, consumer groups, testing laboratories, governments, engineering professions and research organizations.

LIBNOR is a common platform for technical discussions assembling around 200 experts as members in the technical committees, representing the private and public sectors, universities, research centers, laboratories, NGOs and other interested parties.

International standards are adopted as Lebanese standards according to the WTO/TBT Code of Good Practice, however, where international standards do not exist, especially for specific Lebanese products; LIBNOR turns to a specific elaboration process where scientific studies are conducted.

LIBNOR is now participating in the international standardization through its membership in around 16 ISO technical committees, such as : ISO/TC 176 "Quality Management and Quality Assurance", ISO TC 207 "Environmental Management", ISO /IEC JTC1 " Information Technology", ISO TC 34 " Food Products", ISO TC 59 "Buildings and civil engineering works, ISO TC 138 "Plastics pipes, fittings and valves for the transport of fluids" etc...

NL Conformity Mark

NL Conformity Mark is a mark owned by the Lebanese Standards Institution (LIBNOR), as per law of 23-07-1962. The NL Conformity Mark indicates the conformity of certified products and goods to national standards. LIBNOR shall grant the right to use it for those who are interested on conditions, to be defined by LIBNOR.



Importance of NL Conformity Mark

Conformity Mark increases the level of customer confidence and facilitates national, regional and international trade. In fact, it will help:

- Improve the quality of Lebanese products
- Increase the level of consumer confidence in Lebanese products
- Prepare Lebanese manufacturers to get familiar and eventually comply with the requirements of the Conformity Marks of other countries especially European countries (e.g NF, BS, DIN, CE, etc.), thus increasing and facilitating Lebanese exports to the EU.
